***Well variances are pulled by the well driller or homeowner's for various reasons. Some examples would be:**

- **Does not meet distance requirements**
- **Total volume of sealing materials were less than required amount**
- **Drilled well before obtaining well permit**

***Penalty Fees are for wells that are drilled before obtaining proper permits. These can be paid for by the well driller or homeowner.**

AMENDED RESOLUTION 101

LOCAL HOME SEWAGE RULES

This said regulation of the Carroll County Board of Health, is considered in order to establish local rules and categories and to declare an emergency.

This regulation is hereby declared to be an emergency regulation necessary for the immediate preservation of public health. Such an emergency is due to the absence of state rules. Said absence of any state rules may cause delays or disruption s of public health services. Rules to direct activities pertinent to the permitting and installation of home sewage systems and amends Resolution 101 to include language required by the Ohio Department of Health guidance document issued July 1, 2007.

Therefore, under the authority of Section 3709.20 and 3701.09 of the Ohio Revised Code, be it resolved by the Board of Health of Carroll County.

**RESOLUTION NO. 601-EE
REGULATION ESTABLISHING CERTAIN FEES IN THE
CARROLL COUNTY GENERAL HEALTH DISTRICT**

This said regulation of the Carroll County Board of Health, is considered in order to revise program fees, categories and to declare an emergency.

This regulation is hereby declared to be an emergency regulation necessary for the immediate preservation of public health. Such an emergency is due to the absence of an adequate fee schedule and the lack of time and data necessary in which to create one. Said absence of any fee schedule may cause delays or disruptions of public health services. Adequate funding to cover costs of the program is critical to the program's effectiveness in protecting public health, safety and the welfare within the county.

Therefore, under the authority of Section 3709.20 and 3701.09 of the Ohio Revised Code, be it resolved by the Board of Health of Carroll County, that the following regulatory fees be adopted.

EXPLANATION OF FEES

Application for site review: HSTS..SFOSTS

1. \$80.00 – Lower this fee due to review only of property and paperwork. (Not doing the soil work).
2. \$300.00 – Permit to install. Raised to cover cost of employee/trainings/2 inspections instead of one.
3. \$100.00 – Had to set a fee but we are not doing it.
4. Alter HSTS \$250.00 with all the requirements and reviews of designer plan and visit to site/2 inspections.
5. Alter SFOSTS – Not doing it, had to set fee.
6. Operational Permits \$35.00 – Maintain database, homeowner education, sending reminders/pumping. Homeowner must send us information about pumping (when they pumped)
7. Not doing, had to set fee.
8. Registration for Installers - \$150.00
 - Service Providers - \$150.00
 - Septage Haulers - \$150.00 + \$50.00 per/truckService provider (new) systems with a mechanical component must have a service provider on contract every year. (most installers will be service providers as well)
9. Vehicle permits
10. Variance – Same \$200.00
11. Unauthorized install – Same \$250.00
12. HSTS & SFOSTS Evaluation - \$80.00 – Loan Inspections on existing systems.
13. Service Contract Inspections - \$80.00 + lab costs for homeowners who don't maintain their own service provider.
14. Self Explanatory
15. Soil Survey if we start to do it setting the fee at \$250.00
16. Lot Split - \$50.00 from Regional Planning.
17. Proposed Subdivision Review - \$125.00 + \$12.50 for every lot over 5 (paperwork only and lot layout, this is not the soil work). Review of soil information from soil scientist.
